



" As per prohibition notification issued by the Ministry of Labour, Govt. of India under section 10 of The Contract Labour (Regulation & Abolition) Act, 1970 and as per directives of the Ministry of Railways , Departmentalization of the contractual activities of Checking assistants and Safaiwalas only have been done. But question of absorption of other categories of contractual workers working under different contracts of various departments of Metro Railway, Kolkata does not arise".
