Respected Sir,

Sri O. Sundara Ramaiah, Rtd. Railway Employee, is not eligible continue as either office bearer of the South Central Railway O.B.C Employees Association or the General Secretary of the All India O.B.C Railway Employees' Federation from the date of his retirement as per the clause 16 of the All India O.B.C Railway Employees' Federation and as per Railway rules. Hence, he should not get any privileges including card pass after his retirement. But O. Sundara Ramaiah has been deliberately stating that he can manipulate the concerned officials with money (bribe) to bypass this hindrance to continue in the Society and get the facilities even after his retirement. In this connection, the following information is required, to arrest his further illegal acts in the larger interest of Railways. Therefore I, the undersigned request you to kindly furnish the following information under RTI Act - 2005 to arrest their further illegal activities in the interest of Nation and justice.

Please furnish the details of action taken by the Hon'ble Chief Minister of Delhi and other concerned officers on the enclosed Federation letter No. AIOBCREF / IR / GBM / ELECTION / 2014 dated 24.08.2014, which was submitted in the year 2014 to the Registrar of Societies, Railway Board and all concerned. And also furnish Para wise remarks and all the file notings & pages in connection with the above mentioned letter.
