"Rajiv Gandhi National Crèche Scheme (RGNSC) was launched w.e.f. 1<sup>st</sup> January,2006 to provide day care facilities to children (age group of 0-6) years of working and other deserving women belonging to families whose monthly income is not more than Rs. 12,000/-. The Scheme has been revised w.e.f. 01.01.2016 for its continuation during the remaining part of the 12<sup>th</sup> Five Year Plan. As per revised scheme, the crèche facility is provided to the children of age group of 6 months to 6 years of working mothers who is employed for a minimum period of 15 days in a months, or six months in a year. The scheme provides supplementary nutrition, health care in puts like immunization, polio drops, basic health monitoring, pre-school education (03-06 years) and emergency medicine. This scheme is being implemented presently through the Central Social Welfare Board (CSWB) (an autonomous body under the Ministry) and Indian Council for Child Welfare (ICCW) (an NGO). Details of scheme i.e. the guidelines, application format, eligibility, criteria for NGOs is readily available at the Ministry's website [www.wcd.nic.in](http://www.wcd.nic.in) under the heading schemes/Women Empowerment Scheme.
